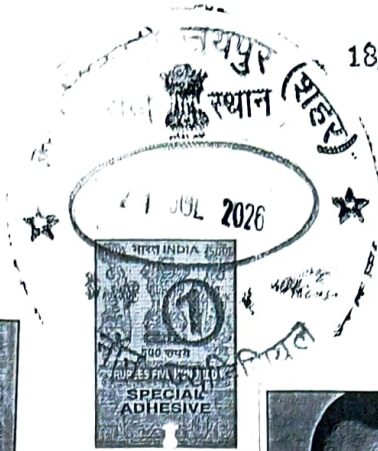




AGREEMENT

AND WHEREAS based on the representation of the VIFT, AWPEM has agreed to engage its services on the terms and conditions as mutually negotiated and agreed more particularly set out herein below at the premises located at Udaipur.

NOW THEREFORE, in consideration of the premises, mutual agreements and covenants contained in this Agreement and other good and valuable consideration (the receipt and adequacy of which is hereby acknowledged), the Parties hereto agree as follows-

1. DURATION:

This Agreement shall be in force till **1 Year**(Session 2026-27) unless mutually terminated by the Parties. The Agreement may be further renewed for a period and on the terms and conditions as may be mutually agreed by the Parties in writing.

2. INTELLECTUAL PROPERTY RIGHTS:

VIFT and AWPEM mutually acknowledge and agree that all trademarks, logos, brand names, training courses, course materials, PPTs, SOPs, marketing materials, learning materials, syllabus and all other intellectual property developed, owned or provided by AWPEM, Jaya Education and/or their respective associates or affiliates shall remain their sole and exclusive property, and VIFT shall have no ownership or proprietary rights therein. VIFT shall not copy, duplicate, reproduce, misuse, modify, distribute or use any such intellectual property, study materials or AWPEM branding without prior written consent of AWPEM. The AWPEM logo may be used by VIFT only with prior written permission and solely for approved marketing or promotional purposes. Subletting of the Training Centre or operating multiple Training Centres under a single Agreement shall not be permitted. Any change in the subjects or syllabus shall require prior written approval from AWPEM. Any violation of these provisions shall constitute a breach of this Agreement and AWPEM shall have the right to take appropriate legal action at its discretion. Both parties hereby acknowledge and consent to the above terms and agree to comply with the same.

3. INDEMNITY:

VIFT and AWPEM, hereby undertakes to indemnify and keep indemnified the other party against any loss, claim, damage, liability, cost, charge, expense, compensation, or inconvenience arising out of or resulting from any breach of duty, negligence, false or misleading promise, commitment or representation, or misuse of intellectual property rights by such party in connection with the performance of its roles and responsibilities under this Agreement.

4. TERMINATION

Either **VIFT** or **AWPEM** may terminate this Agreement by giving ninety (90) days' prior written notice to the other Party. Notwithstanding the foregoing, **AWPEM** shall be entitled to terminate this Agreement with immediate effect in the event of any transgression, breach of the terms of this Agreement, or any misconduct by **VIFT** which, in the reasonable opinion of **AWPEM**, renders continuation of the arrangement impracticable. Notwithstanding termination for any reason, **VIFT** shall remain responsible to **AWPEM** for all students/trainees mobilized and introduced by **VIFT**, including matters relating to background verification. **VIFT** shall immediately return to **AWPEM** all study/course materials, marketing collaterals, documents, and any other materials belonging to or provided by **AWPEM** that are in its custody or possession.

5. ASSIGNMENT:

Neither VIFT nor AWPEM shall assign, transfer, or otherwise dispose of this Agreement or any interest therein in favour of any third party without the prior express written consent of the other Party. Any such assignment or transfer shall be valid only upon obtaining the prior written approval of the non-assigning Party.

6. GOVERNING LAW AND ARBITRATION:

Neither VIFT nor AWPEM shall assign or transfer this Agreement, or any interest therein, without the prior express written consent of the other Party. Any dispute or claim arising out of or in connection with this Agreement, including any breach, termination or invalidity thereof, shall first be resolved through mutual discussions between VIFT and AWPEM; provided that any breach shall have remained uncured for a period of 90 days from receipt of written notice thereof. If the dispute remains unresolved, it shall be finally settled by arbitration by a Sole Arbitrator mutually appointed by VIFT and AWPEM, in accordance with the Arbitration and Conciliation Act, 1996. The seat and venue of arbitration shall be **Jaipur as well as Udaipur, Rajasthan**, and the proceedings shall be conducted in English. This Agreement shall be governed by and construed in accordance with the laws of India, and the JURISDICTION AREA for any legal proceedings will be Jaipur or Udaipur as per the requirements.

7. REVENUE SHARING MODEL:

1. Collaborative JMC & Event Management Course – ₹60,000 Fee

VIFT and AWPEM mutually agree to jointly introduce **JMC & Event Management Course** at a total fee of **₹60,000 (Rupees Sixty Thousand only) per student/trainee**. AWPEM shall be providing the necessary course content for event management studies. The course duration, curriculum, training methodology, admissions, and other academic matters shall be mutually decided by VIFT and AWPEM. The fee collected from each student shall be shared equally between the parties, with **50% payable to VIFT and 50% payable to one part (Jaya Education)**. VIFT shall provide AWPEM with complete admission and fee-related details of each enrolled student/trainee and the respective share shall be settled within **7 days from the date of receipt of the student's fee**. VIFT shall undertake all the marketing promotions, delivery, and administration of the course and shall perform theresponsibilities in good faith with mutual cooperation.

2. Certificate Course in Event Management – 6 Months - ₹40,000 Fee

VIFT and AWPEM mutually agree to jointly conduct a **Six-Month Certificate Course in Event Management** at a total fee of **₹40,000 (Rupees Forty Thousand only) per student/trainee**. The course shall be conducted for a period of **six (6) months**, with the curriculum, training structure, schedule, and academic requirements to be mutually finalized by VIFT and AWPEM. The total fee collected from each student shall be shared equally, with **50% payable to VIFT and 50% payable to one part (Jaya Education)**. VIFT shall furnish complete admission and fee-related details to AWPEM at the time of enrollment/registration, and the respective share shall be settled within **7 days from receipt of the student's fee**. VIFT shall undertake all the marketing promotion, management, training, and successful execution of the course with mutual cooperation.
